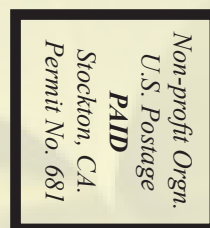

Dr. Carol Bartz worked in public schools in Illinois and California for over 39 years. She has been a LSH Specialist, Resource Specialist, Program Specialist, Diagnostician, Director of Pupil Services, and Principal of an inner city elementary school. She recently retired as the Senior Director of the North Inland Special Education Region (SELPA) in San Diego County. While serving as the SELPA Director, she coordinated the development of the Communication Severity Scales (CSS), which is used by LSH specialists throughout California. Dr. Bartz has presented staff development workshops at universities, as well as at national, state, and local professional conferences. In her retirement, she is working with school districts on program development and special education finance.

Jan Birrenkott is a Speech/Language Pathologist with 32 years of experience with children of school age. She was instrumental in the advanced development of the Communication Severity Scales (CSS) and has utilized the CSS in schools for many years. She has presented at ASHA, 1985 in Detroit, Michigan on Metaphor Comprehension with Language Delayed children and twice at CASHA on the Communication Severity Scales. She served as the Mentor for her school district during the last 15 years of her work experience.

- Speech/Language Therapists

This workshop will share the development and utilization of the Communication Severity Scales (CSS). The CSS were developed by the LSH workgroup in the North Inland SELPA in San Diego County. The CSS are designed to address the need for using assessment data and professional expertise to recommend the appropriate level of speech and language services for individual students for consideration by the IEP team. Tools will be shared for determining when an assessment is indicated for potential speech or language disabilities for EL students. Participants will utilize the information for students on their caseloads to apply the CSS.

After completing this program, participants will be able to:

1. Explain the legal requirements and parameters for providing LSH services to students with disabilities in the public schools
2. Implement the prereferral process to determine appropriate assessments
