- I. CALL TO ORDER: Brandie Brunni called the meeting to order at 8:57 a.m.

Director headshots were completed outside of the WEC.

2. SELPA vs. Special Education - Brandie

Brandie reviewed the difference between SELPA and County Programs.

3. PY July Annual Accrual AB602 - Austin

Austin shared updates regarding the funding model as it applies going into the 23-24 school year. Items shared included an update with funds to AB130, which increased funds for this year as it rolled over from last year. There was also an increase in salaries and benefits which further adjusted the model. District revenue for 22-23 was shared. A comparison of estimated actuals, to actual accrual was presented. Funding factor is the percentage of funds that districts get back, which is currently higher than it has ever been.

4. PY Ann Review Excess Cost Transportation - Austin

Austin shared a brief overview of how excess cost transportation is calculated. Biggest change for this year is the reimbursement for transportation which gave us an extra 2.5 million dollars towards transportation.

### 5. PY Annual Accrual Mental Health Allocation - Austin

This is the model that the state changed for the 23-24 school year as the money goes straight to the districts, and then districts will journal to the SELPA for mental health costs. There is money carried over from the prior year that will be given back to districts due to the funding model change. Must be able to justify how dollars are spent and how they tie into mental health.

## 6. SELPA Funding Model - Austin

Austin explained the current model vs the new model that will be proposed at the Governing Council Meeting next week. There will be an action item proposing a change in the funding structure. The action item will affect the 24-25 school year.

# 7. Scheduling LEA Site Visits - Brandie

Brandie shared the link to sign up for site visits for the 2023-2024 school year.

# 8. Special Education Legal Summit - Brandie

Brandie shared that this event will be held on September 27th, 2023, and encouraged sign ups. Information to be shared by GPV law firm.

### 9. County Programs Update - Monica

Monica reviewed with LEAs their individual packets which included referral numbers, including types of referrals sent to county programs. A 5 year comparison was also shared, using 2018-2019 data as a "regular" year prior to covid.

Preliminary projections were shared from 6 months ago that showed class sizes for the 23-24 school year, compared to current enrollment and referrals in progress. County programs need growth in order to continue to be able to support LEA student needs.

Staffing Update was reviewed including current instructional assistant and teacher vacancies.

### 10. Alternate Pathway to Diploma - Jody

The Alternate Pathway to Diploma program was discussed including current CDE requirements. There are still many questions remaining, and Algebra is a major

roadblock to completion for many students. Frank will continue to gather information, and start a workgroup to help our SELPA move forward.
